2020 HCES LIFETIME ACHIEVEMENT AWARD SAMUEL DANNAWAY

The Hawaii Council of Engineering Societies (HCES) is pleased to announce that Samuel Dannaway, PE, FSPE is 2020's HCES Lifetime Achievement Award recipient. Sam was selected for this prestigious honor for his tireless dedication to the fire protection engineering profession both in Hawaii and nationwide.

Sam has been Vice President of Fire Protection Engineering at Coffman Engineers, Inc. since the company acquired S.S. Dannaway and Associates (SSDA) in 2016. Sam was President at SSDA, established in 1985 as the first full-service fire protection engineering consulting firm within the State of

While attending the University of Maryland, he also was a volunteer fire fighter and EMT at Silver Hill Volunteer Fire Department and Rescue Squad. Originally enrolled in pre-med, his interest in firefighting drew him into the fire protection engineering program, where he graduated with a degree in Fire Protection Engineering in 1978. In 2018 Sam received his Master of Engineering in Fire Protection Engineering.

Sam came to Hawaii in 1979 from the Chesapeake Division of the Naval Facilities Engineering Command (NAVFAC) to the Pacific Division at Pearl Harbor. He left the federal government for the private sector in 1985.

He has performed fire protection engineering services on thousands of projects including a multitude of military work that includes health care, housing, schools and armories among many other diverse project types. With the addition of SSDA staff, Coffman is now a major source of FPE expertise for aircraft hangar fire protection.

In 1985 Sam was the only licensed FPE in Hawaii in private practice. In part, through his efforts, there are now more 40. A vigorous advocate of



mentoring young engineers and continuing professional development for all engineers, Sam continues to work with SFPE to help bring training seminars to Hawaii from NFPA, SFPE, and others. He has coached dozens of individuals by leading several Fire Protection Engineering PE exam study groups.

His mentoring efforts fostered several former employees who have gone on to successful careers in Hawaii and Japan as FPEs with other consulting firms and other federal agencies including the Army Corps of Engineers, Honolulu District, Japan Engineering District, and Far East District, as well as, NAVFAC Hawaii and Pacific and Pacific Air Force.

Sam is a licensed Mechanical Engineer in Hawaii and a licensed FPE in California and Guam. Since 1992, Sam has frequently lobbied the Hawaii State Board of Professional Engineers, Architects, Surveyors and Landscape Architects to recognize fire protection engineering and to offer the NCEES exam.
